ECG CALLS FOR ACTION ON TRUCK STOPPAGES

Industrial action harms industry and workers

ECG has called for immediate action by the Italian government to prevent wildcat industrial action causing further disruption to the country's auto industry supply chain.

"Owners of small car-transport businesses in Italy have been protesting for some time over the current difficult economic climate, and we have sympathy for their predicament" said ECG.


"At the same time, we cannot accept protests that block access to car factories, terminals and compounds. Such action threatens the livelihoods of millions of workers and creates financial losses running into the tens of millions of euros for automakers, dealers and logistics operators themselves."

ECG urged the authorities to intervene where such protests threaten the work of other sectors of the business by blocking access to such facilities. Thus far, Italian logistics operators have worked hard and relatively successfully to repair the damage caused by this industrial action, but it is taking a toll nonetheless.

These small business owners — whether lone operators or running small fleets of car transporters — have suffered badly through the economic crisis. Over the last month, however, they have taken to expressing their discontent and publicising their somewhat unfocussed demands, by parking their vehicles where they can cause maximum disruption, often blockading key industry sites such as car plants and compounds.

The resulting turmoil could not come at a worse time for the Italian auto industry as a whole, which is struggling in the face of weakening demand and tumbling sales volumes. At a time when the automotive industry needs to operate as efficiently and productively as possible in order to keep its head above water, the supply chain must be protected.
